### A. TESCO/HOMEBASE

#### **Petition to reject approval for redevelopment**

We're running a petition for the Mayor of London and/or the Secretary of State for Housing, Communities and Local Government to reject Hounslow Council's recent approval of the planning applications to build tower blocks on the Tesco & Homebase sites. We firmly continue to believe that Hounslow's housing aims can be achieved by developments which are more sympathetic to the area and meet Hounslow's housing needs for family-sized homes.

If you click on this link [Reject planning approval to redevelop Homebase & Tesco Sites, Syon Lane | 38 Degrees](#) it should take you straight to the on-line petition. Please sign it (with all members of your household aged 16 and over), and circulate it to your friends, neighbours and WhatsApp groups in the area. We will promote the petition via social media, and are also running a paper-based petition for those who don't have access to the internet. So, if you have a neighbour or local friend who you know isn't on the internet, then you might want to print off the attached petition for them to sign, and return it to us by Friday 7 May (to 130 Wood Lane, Osterley, TW7 5EQ).

We are also looking for volunteers who would knock on some doors locally to get more signatures. If you have some time to do that, please e-mail us on [info@owgra.org.uk](mailto:info@owgra.org.uk). Some of our Street Reps are already out and about obtaining signatures.

The petition has started off well, with almost 400 signatures since it was launched yesterday and that's before it's been promoted on social media and before you've received notification of it. We have set ourselves a target for a combined total of over 2K signatures for the on-line and paper petition.

It's inevitable that there might be some crossover with people signing both the on-line and paper petition but we will try to delete any repeat submissions.

#### **Transcription of 8 April Planning Committee meeting**

We do need to transcribe the Planning Committee meeting, and some of us have already made a start on that, so if you can help with this then please let us know. #### **Other actions being taken to overturn the planning decision**

We are sending letters listing our concerns and objections to the Mayor of London and Secretary of State for Housing, Communities and Local Government, and are seeking legal advice to see what other avenues are open to us to challenge this decision that will transform part of this area of West London into a sea of 16 tower blocks.

We have written a 7-page letter of complaint to the Chief Executive of Hounslow Council about the format and management of the Planning Committee meeting of 8 April and the lead up to it. We have received an unsatisfactory response and will be responding to that with further comments. We've already sent another 2-page letter with other issues that have become apparent as a result of listening to the meeting again. **C. LONDON ELECTIONS, THURSDAY 6 MAY**

Elections for the Mayor of London and London Assembly Members are only 10 days away. Apart from election leaflets from various parties and candidates, you should have received a detailed booklet explaining the elections and listing all the candidates. OWGRA recently took part in some hustings where we challenged four candidates (Green, Labour, Lib Dem & Tory) to represent our constituency of London South West (covering the 3 boroughs of Hounslow, Richmond and Kingston) with questions about planning. Our question to the candidates was simple: **“How would you drastically overhaul the failed planning process in Hounslow to build some level of trust and transparency into the system?”** None of the candidates gave a satisfactory answer. We were unable to respond after the candidates responded but below are some points of clarification.

Nick Rogers (Tory) reference to neighbourhood planning:

Despite the Localism Act 2011, setting up a neighbourhood forum is fraught with difficulty. Some Councils are more in favour of them than others (Hounslow is opposed to them). We tried to set one up in Osterley & Spring Grove ward in the early 2010s, but were thwarted by Hounslow Council who deleted all the green areas when designating the neighbourhood area (probably because they hope to build on those areas eventually), so nothing ever came of it.

Gareth Roberts' (Lib Dem) reference to objections often not being based on planning policies:

We spent a lot of time distributing 5 newsletters over the last 8 months to the 5K households in our area and e-mailing our 500 members every few weeks, stressing that objections needed to be based on planning grounds. The list of objections in the Hounslow Officers' reports to the Planning Committee members shows that we did achieve that on the whole.

Candice Atterton (Labour) reference to us being late with submitting some documents:

We met all the deadlines and submitted high-quality evidence-based objections in contrast to the subjective, often unsubstantiated, comments made in the Officers' reports and at the Planning Committee meeting.

OWGRA is apolitical and we can't suggest who you should vote for, but listening to the responses of the candidates might help you decide who you would like to represent you.
