## 02/07/20 Meeting

- 11.1. Following the above email correspondence, a meeting was organised with the councils appointed air quality and noise consultants, WYG. Peter Henshaw (BuroHappold- Senior Air Quality Consultant), Connor Rusby (BuroHappold- Air Quality Consultant) and Nigel Mann (WYG- Director of Noise, Air Quality, Lighting and Odour) were present at this meeting.
- 11.2. The methodology of the report was presented to WYG, with particular emphasis on the

verification process. The modelled outputs from the ES chapter were presented and compared with results from the councils existing model and the concentrations predicted at similar locations were comparable across the most impacted areas of the project site.

11.3. The choice of background concentrations to be used in the assessment was also discussed. Background concentrations from Defra background maps were used for the baseline (2019) scenario and it was agreed the same background concentrations were to be used in future scenarios in the interest of a conservative assessment.
